# Minutes Tanque Verde Valley Fire District

#### 1. Roll Call

Approval of the December minutes had to be postponed until next meeting, no vote took place.

#### 2. Old Business

A. Discussion and vote on contract proposal for fire hydrant project.

Discussion took place regarding the work order and cost. Bruce Small is a surveyor and will provide topography and survey at no charge.

Preliminary opinion and probable cost was \$16,857.50 that includes Bruce Small's topography and survey at no charge. The work order cost is included in the preliminary opinion. JAE included his experience, qualifications, etc. with proposal.

Cost estimate by Tucson Water was \$17,000. As a result of having JAE do it, they will do permits and take care of everything. If Tucson Water did it, Board would have had to get permits and anything else that would be needed.

Bob Jones made a motion to accept JAE and his sub-contractor (Collins Excavating). Roger Robinson seconded the motion. It was passed with a 2-0 vote.

Bob Jones found out from the County Assessor's office that there is a wash that intersects the parcels of land. The wash splits the property and was not included in the original map given to the assessor's office. An addendum needs to be filed showing the wash and its location to the 3 parcels. Parcel #1145780.

On 1/16 there will be a public meeting for public input for the Desert Willow Ranch.

### 4. Fire Chief's Report

During December, 2013 there were 11 calls for service. 4 were emergency, 7 were non-emergency

Rural Metro is out of Chapter 11 bankruptcy process. They are moving forward in their plan.

Training to be conducted in February for the new radio system (PCWIN).

Station 72 is getting a 4 wheel drive ambulance. This vehicle is already housed at this station.
