Minutes Tanque Verde Valley Fire District

The Tanque Verde Valley Fire District Governing Board met on Wednesday, February 19, 2014 at 7:00 p.m., at the Tanque Verde Unified School District Facility, 2300 N. Tanque Verde Loop Road, Tucson, AZ 85749.

1. Roll Call

Meeting called to order at 7:05 p.m.

The Pledge of Allegiance was bypassed as there was no flag present.

Approval of the December and January minutes took place. December meeting minutes had to be postponed until this meeting, as not everyone was present at the previous December meeting. Roger Robinson made a motion to approve December and January minutes. Approval was unanimous by a 3 to 0 vote.

3. Old Business

A. <u>Update of correction of legal description for the annexation of Desert Willow</u> <u>Ranch subdivision.</u>

Bob Jones' original map had a different description than their actual description. The Title Company recorded deed description. They then recorded a scrivener's error. Bob Jones then had to go back and re-record with assessor's and recorder's offices. While doing so he noted another scrivener's error and had to fix that one too.

He then put together another package of materials detailing all corrections, etc. which Bob Jones gave them to Roger Robinson to have them recorded. Bob Jones had received the original paperwork from RW Price (developer).

B. Update of status of possible need of new recording equipment and cost.

Bruce Small has 2 recorders, one is the size of a cigarette lighter, the other is a larger one that no one has yet figured out how to operate. He asked if we should buy a Puma 4. Bob Jones made a motion to purchase the Puma 4. Roger Robinson seconded the motion. Unanimous approval, by a vote of 3 to 0, to have Clerk Bruce Small purchase the recorder upon the opportunity.

C. <u>Update on progress for scheduling of training for members on website</u> <u>development.</u>

Bruce Small is scheduling training. Roger Robinson gave his available dates. All wish to take the training together.

D. Verification of Bruce Small as next board member on election ballot.

Bruce Small needs to fill out paperwork packet. Roger Robinson will pick up the elections packet of paperwork.

D. Discuss review of recent changes in Record Management and Retention.

Roger Robinson will review to see if any changes are needed in the current procedures of recording of permanent records by the TVVFD.

5. Fire Chief's Report

During January, 2014 there were 6 calls. 3 were emergency, 3 were nonemergency. 100% contract compliance.

PCWIN – April 3 at 0400 hours is the cutover date for Rural Metro. Bob Jones has a record of the permanent equipment. Rural Metro has verified that they are responsible for maintenance of the radio equipment.

6. <u>Treasurer's Report</u>

At the beginning of January the beginning balance was \$ 159,675.41 At the end of January the ending balance was \$ 161,472.36

Roger Robinson gave Bob Jones the fire district levy worksheet, and secondary values for the Fire District.

Bob Jones will give to Roger Robinson the annual audit information to review and file within the permanent record.
